To begin, we ask you to develop a true appreciation for what our downtown still has to offer—it really is an attractive area that is rich in history— and realize that the best thing you can give it right now is you. We hope the eclipse event we are hosting on Main Street next Monday will encourage you to enjoy downtown Newcastle for a couple of hours and reconnect with that part of the community. We are inviting folks from neighboring communities to join us that day as well, and while we can't offer the number of shops and businesses that other towns can at present, we can offer a pretty good day with some pretty good people in a pretty attractive place— and that's often all visitors to this part of the country are looking for.

We thank the sponsors of the eclipse event—First State Bank, Black Hills Dental, Black Hills Energy, Dixon Brothers and Pinnacle Bank— for their investment in this effort to create a little spark on Main Street, and hope you'll invest in it as well by simply making your way downtown to join the fun.

AN ORDINANCE AMENDING SECTION 3-5 OF ARTICLE II, CHAPTER 3 OF THE CODE OF THE TOWN OF THE CITY OF NEWCASTLE, WYOMING, 1961 TO ESTABLISH HOURS FOR DISPENSING OF ALCOHOLIC AND MALT BEVERAGES BY LICENSEES AND PERMITEES; AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEWCASTLE, WESTON COUNTY, WYOMING, THAT:

SECTION 1: Section 3-5 of Article II, Chapter 3 of the Code of the Town of the City of Newcastle, Wyoming, 1961 shall be, and hereby is, amended to read in complete form as follows: "Sec. 3-5. Hours for dispensing.

(a) Excluding permittees of catering and malt beverage permits, and subject to such additional restrictions and limitations as provided by applicable state statutes, no licensee or permittee shall sell or otherwise dispense, serve or deliver any alcoholic or malt beverage except during the hours from 6:00 a.m. through 2:00 a.m. on the following day except and unless otherwise specifically authorized by the City.

(b) Notwithstanding subsection (a) of this section, permittees of catering and malt beverage permits shall not sell or otherwise dispense, serve or deliver any alcoholic or malt beverage except on the day(s) and during the hours authorized by the City.

(c) Excluding permittees of catering and malt beverage permits, no licensee shall allow or permit the consumption of alcoholic or malt beverages in the licensee's licensed building or any other area where the licensee is authorized to sell or otherwise dispense, serve or deliver alcoholic or malt beverages during the hours from 2:30 a.m. to 6:00 a.m. except and unless otherwise specifically authorized by the City."

SECTION 2: This Ordinance shall become effective after passage and upon publication as provided by law.




