These are considered "Federal Elections" because candidates for United States Representative appear on these ballots. By resolution, the Weston County Board of Commissioners can request an election to be held in odd numbered years.

### **Absentee Voting**

For the convenience of Weston County voters, absentee ballots can be obtained at the Weston County Courthouse, in the Clerk's Office, 1 West Main, Newcastle, Wyoming. The Weston County Clerk's Office is open from 8:00 a.m. until 4:30 p.m. Monday through Friday.

### Registered voters wishing to cast an absentee ballot may:

Request an absentee ballot in person at the Weston County Clerk's Office.

Call (307) 746-4744 to request a ballot which will be mailed to the address provided.

All mailed absentee ballots must be received in the Clerk's Office by 7:00 p.m. on the day of the Election to be counted. Absentee ballots brought to the Clerk's Office must be received by Aug. 19 by 7 p.m.

### **Voter Registration**

Voters may register at the office of the County Clerk. To register to vote in Weston County you: Must be 18 years of age on Election Day Must be a resident of Weston County Must withdraw voter registration from any other jurisdiction, if applicable Must not be a convicted felon or adjudicated mentally incompetent Must have valid photo identification Persons who meet the above qualifications may also register to vote at the Polling Place on Primary



The Law Enforcement Pension Plan is adequately Passed – Senate 29-1, House 43-13 Allen Slagle voted NO funded with almost one billion dollars to help surviving spouses and their dependents in their time of need.

HB0029 – This bill requires the Division of Criminal Investigation to develop and maintain a cold case database. It has a fiscal cost of \$150,000, this was common sense legislation. Passed – Senate 26-4, House 53-9 Allen Slagle voted NO

HB0027 - DFS and law enforcement-cross reporting requires law enforcement to notify the Department of Family Services upon receiving a report that a vulnerable adult is suspected of being or has been abused, neglected, exploited, intimidated, or abandoned or is committing self-neglect. Passed – Senate 21-10, House 44-17 Allen Slagle voted NO
